Tanker/Vehicle Accident	Switch off engine and electrical equipment. Keep people away, warn other traffic. Check for spills, leaks. Call the emergency services: Dial 111
Spill or leak	Wear PVC overalls, chemical resistant gloves, facemask or goggles. Prevent further spillage. Adsorb spilled product and place in sealable container for disposal. Wash down affected area with water plus detergent. Contain spillage. Absorb and collect washings and place in the same sealable container for disposal. Seek advice from the local authority regarding disposal. Avoid contamination of any water source or soil with product or empty container.
Fire	Call the Fire Service: Dial 111. Wear full protective clothing and breathing apparatus. Extinguish fires with water, foam, dry chemical or carbon dioxide.
