**EMERGENCY PROCEDURES 24 HOUR ADVICE IN AN EMERGENCY ONLY: 0800 243 622 (CHEMCALL)**

IF THIS HAPPENS	DO THIS
<b>Tanker/Vehicle Accident</b>	Switch off engine and electrical equipment. Keep people away, warn other traffic. Check for spills, leaks. <b>Call the emergency services: Dial 111</b>
<b>Spill or leak</b>	Wear PVC overalls, chemical resistant gloves, facemask or goggles. Prevent further spillage. Adsorb spilled product and place in sealable container for disposal. Wash down affected area with water plus detergent. Contain spillage. Absorb and collect washings and place in the same sealable container for disposal. Seek advice from the local authority regarding disposal. Avoid contamination of any water source or soil with product or empty container.
<b>Fire</b>	<b>Call the Fire Service: Dial 111.</b> Wear full protective clothing and breathing apparatus. Extinguish fires with water, foam, dry chemical or carbon dioxide. During a fire toxic fumes may be released. Cool sealed drums with water to prevent rupture due to thermal expansion. Contain run-off. Keep non-involved persons away.

**FIRST AID 24 HOUR ADVICE IN A FIRST AID EMERGENCY ONLY: 0800 POISON (0800 764 766)**

<b>If Swallowed</b>	Do NOT induce vomiting. Rinse mouth and drink a glass of water. <b>For advice contact the National Poisons Centre 0800 POISON (0800 764 766) or a doctor immediately.</b> If symptoms persist, get medical attention.
<b>If in Eyes</b>	Hold eyelids apart and flush the eye continuously with running water for at least 15 minutes. Get medical attention.
<b>If on Skin</b>	If skin or hair contact occurs, remove contaminated clothing and flush skin and hair with running water. Do not scrub the skin. Wash skin thoroughly with soap and water.
<b>If Inhaled</b>	Remove patient to fresh air. If not breathing, give artificial respiration, preferably mouth-to-nose. Get medical attention if symptoms develop.

**STORAGE AND SEGREGATION SUMMARY**

**Storage:** Store at room temperature (i.e. 5 to 25 °C) in original container in a cool, dry, ventilated place away from direct heat or direct sunlight. Store away from foodstuffs, children and animals. Keep container sealed when not in use.

**Aggregate Storage Volume Thresholds:** When stored with substances of the same hazard the aggregate quantity must be considered. For full details refer to the current NZS 8409 Management of Agrichemicals and the HSNO Regulations.
